INVITATION FOR NEGOTIATED PROCUREMENT

(Negotiated Procurement - Two-Failed Biddings)

1. Pursuant to Section 53.1 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Department of Education - Schools Division of Negros Oriental, through its Bids and Awards Committee (BAC), invites technically and financially capable bidders to participate in the negotiation for the project: CY 2022 Basic Educational Facilities Fund (BEFF) Construction of Health Facilities Program (BATCH 1) - (Jose R. Remollo ES (Cambaloctot ES), Siapo ES, & Crisostomo O. Retes NHS - San Jose, Negros Oriental) (Negotiated Procurement) with a total Approved Budget for the Contract (ABC) of Four Hundred Ninety One Thousand Three Hundred Fifty Six and 66/100 Pesos (Php491,356.66), Details as follows:

3	Construction of Three (3) Units Group Handwashing Facility - For Secondary (Option 2B - without roofing, with counter with painted cement) at Crisostomo O. Retes National High School, San Jose	218,188.87	

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. Negotiations shall be open to all interested bidders. Completion of the Works is required **Sixty (60) Calendar Days**. Bidders should have completed a contract similar to the Project.
- 3. Bidder/s who bought bid documents in any of the two failed biddings will <u>not</u> be charge. A fee of Five Hundred Pesos (Php500.00) will be charge for new bidder/s.
- 4. Negotiations, Submission and Opening of Best Offer will be on **September 1**, **2022**, **2:00 P.M.**, at the School Governance and Operations Division (SGOD) Office, DepEd, Schools Division of Negros Oriental, Daro, Capitol Area, Dumaguete City.
- 5. Bid Proposals shall include the following (on a sealed envelope):

- a. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2 of the IRR; and
- b. Original of duly signed and accomplished Request for Quotation; and
- c. Original of duly signed Bid prices in the Bill of Quantities; and
- d. Duly accomplished Detailed Cost Estimates Form, including a
- e. Summary Sheet indicating the unit prices of construction materials, labor rates, and equipment rentals used in coming up with the Bid; and
- f. Cash Flow by Quarter.
- 6. Interested Bidder/s will be provided with an electronic copy of the Blank Program of Works (POW) Bill of Quantities (c.) and Detailed Cost Estimates (d.).
- 7. The Department of Education Schools Division of Negros Oriental does not assume any responsibility to compensate or indemnity any bidder expenses incurred in the preparation of bid.
- 8. The Department of Education Schools Division of Negros Oriental reserves the right to reject any and all bids, declare a failure, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
