

# CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS

THIS AGREEMENT, made this 23 DEC 2021, \_\_\_\_\_ by and between:

**DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL**, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or "**HOPE**"

-and-

**22 KARATS PRINTING & PUBLISHING HOUSE** with office address at **Jasmin St. corner Vamenta Blvd. Tambo, Carmen, Cagayan de Oro City** represented by its **Representative, NEIL CASTER AYO**, Filipino, of legal age, and hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., **Reproduction of Learning Resources for Lot 3: MTB-MLE Literacy Worktext "Pwerte Ka"** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Two Million Two Hundred Ninety-Five Thousand Eight Hundred Forty-Six Pesos (Php 2,295,846.00)** (hereinafter called "the **Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) Philippine Bidding Documents (PBDs);
    - i Schedule of Requirements;
    - ii Technical Specifications;
    - iii General and Special Conditions of Contract; and;
    - iv Supplemental or Bid Bulletins, if any;
  - (b) Supplier's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (c) Performance Security;
  - (d) Notice of Award of Contract and the Bidder's conforme thereto; and
  - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **SUPPLIER** agrees that additional contract documents or information

prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum **Two Million Two Hundred Ninety-Five Thousand Eight Hundred Forty-Six Pesos (Php 2,295,846.00)** or such other sums as may be ascertained, **22 KARATS PRINTING & PUBLISHING HOUSE** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with its Bid.
  
4. **22 KARATS PRINTING & PUBLISHING HOUSE** hereby undertakes to reproduce **Seventeen Thousand Two Hundred Sixty-two (17,262)** copies of **Grade 3 MTB-MLE Worktext "Pwerte Ka"** with the following specifications:

5. The HOPE hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
