**CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS**

**DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL**, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or "**HOPE**"

-and-

**TOP ASIA FURNITURE PRODUCERS COOPERATIVE**, with office address at #9 Pearl Island Compound Ph-1, Malinis Street, Lawang Bato, Valenzuela City, Philippines represented by its Chairman / Authorized Representative, **KRIZEL G. MALADIONA**, Filipino, of legal age, and hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **HOPE** invited Bids for certain goods and ancillary services, viz., **Procurement of the 10% Allocation of the CY 2022 Basic Educational Facilities Funds (BEFF) School Furniture Program for San Jose Provincial High School, San Jose, Negros Oriental** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Six Hundred Seven Thousand One Hundred Pesos (Php607,100.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

    - iv. Supplemental or Bid Bulletins, if any;
  - (b) Supplier's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

  - (d) Notice of Award of Contract and the Bidder's conforme thereto; and
  - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. SUPPLIER agrees that additional contract documents or information prescribed by the CPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Six Hundred Seven Thousand One Hundred Pesos (Php607,100.00)** or such other sums as may be ascertained, **TOP ASIA FURNITURE PRODUCERS COOPERATIVE** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with his/her/its Bid.
4. The HOPE hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
