

CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS

THIS AGREEMENT, made this DEC 09 2021 day of _____ by and between:

DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or **"HOPE"**

-and-

MAX COPY CENTER with office address at **Door 1 GK Chua Building, Sanciangko Street, Cebu** represented by its **Agent, ROSE MARIE THERESE C. GAMO**, Filipino, of legal age, and hereinafter referred to as the **"SUPPLIER"**.

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., **Provision of Quarter 1 and 2 Learning Resources of SY 2021-2022 Under the Implementation of BE-LCP (Lot 1) "Grade 3 Workbook: World of Words (WoW)"** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Eleven Million One Hundred Ninety-One Thousand Three Hundred Thirty Pesos only (Php 11,191,330.00)** (hereinafter called "the **Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Philippine Bidding Documents (PBDs);
 - i Schedule of Requirements;
 - ii Technical Specifications;
 - iii General and Special Conditions of Contract; and;
 - iv Supplemental or Bid Bulletins, if any;
 - (b) Supplier's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (c) Performance Security;
 - (d) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **SUPPLIER** agrees that additional contract documents or information

In consideration for the sum **Eleven Million One Hundred Ninety-One Thousand Three Hundred Thirty Pesos only (Php 11,191,330.00)** or such other sums as may be ascertained, **MAX COPY CENTER** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with its Bid.


4. **MAX COPY CENTER** hereby undertakes to reproduce **Seventeen Thousand Eighty-Six (17,086)** copies of Grade 3 English Workbook "World of Words (WoW)" with the following specifications:
