CONTRACT AGREEMENT FOR INFRASTRUCTURE PROJECT

THIS AGREEMENT, made this SEP 26 2022 day of _____, by and between:

DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or **"HOPE"**

and

MBBD CONSTRUCTION, with office address at Barangay Buray, Paranas, Samar, Philippines, represented by its General Manager / Proprietor, **MAC DAVE B. DABUET**, Filipino, of legal age, and hereinafter referred to as the **"CONTRACTOR"**.

WHEREAS, the **HOPE** is desirous that the **CONTRACTOR** execute **CY 2022 Quick Response Fund (QRF) Repair of School Buildings Affected by Typhoon Odette - Lot 2 (Siapo Elementary School, San Jose, Negros Oriental)** hereinafter called **"the Works"** and the **HOPE** has accepted the Bid for **One Million Eight Hundred Fifty Thousand Two Hundred Sixty Three and 91/100 Pesos (Php1,850,263.91)** by the **CONTRACTOR** for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:

- (a) Philippine Bidding Documents (PBDs);
 - i Drawings/Plans;
 - ii Specifications/Program of Works;
 - iii Bill of Quantities/Detailed Cost Estimates;
 - iv General and Special Conditions of Contract;
 - v Supplemental or Bid Bulletins, if any;
- (b) Contractor's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - (d) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. CONTRACTOR agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **One Million Eight Hundred Fifty Thousand Two Hundred Sixty Three and 91/100 Pesos (Php1,850,263.91)** or such other sums as may be ascertained, **MDBD CONSTRUCTION** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with his/her/its Bid.
4. The HOPE hereby covenants to pay the CONTRACTOR in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
