CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS

THIS AGREEMENT, made this 18th day of August, 2021 by and between:

DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or **“HOPE”**

-and-

U-BIX CORPORATION, with office address at 1344 Angono St., Makati City; Philippines represented by its Business Solution Officer **KENT MACIAS**, Filipino, of legal age, and hereinafter referred to as the **“SUPPLIER”**.

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., **LEARNING RESOURCES ON THE IMPLEMENTATION OF BE LCP (1,020 ROLLS RISO MASTER CV; 340 PIECES STRIPPER PAD; 117 TUBES INK)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Two Million Seven Hundred Fifteen Thousand Seven Hundred Ninety-Three Pesos and Sixty Centavos (Php2,715,793.60)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Philippine Bidding Documents (PBDs);
 - i Schedule of Requirements;
 - ii Technical Specifications;
 - iii General and Special Conditions of Contract; and;
 - iv Supplemental or Bid Bulletins, if any;
 - (b) Supplier’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - (c) Performance Security;

- (d) Notice of Award of Contract and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Two Million Seven Hundred Fifteen Thousand Seven Hundred Ninety-Three Pesos and Sixty Centavos (Php2,715,793.60)** or such other sums as may be ascertained, **U-BIX CORPORATION** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with his/her/its Bid.
4. The HOPE hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
