Pursuant to Section 53.2 and Section 53.6 (b) of the updated 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Department of Education - Schools Division of Negros Oriental, through its Bids and Awards Committee (BAC), invites technically and financially capable bidders to participate in the negotiation for the project: **Training Venue and Meals for Various Clusters for the Simultaneous 2024 NEGOR School Based Training of Teachers (SBTT)** with a total Approved Budget for the Contract (ABC) of **Php 4,365,720.00 (Four Million Three Hundred Sixty Five Thousand Seven Hundred Twenty Pesos)**, details as follows:



Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. Negotiations shall be open to all interested bidders. Completion of the Works is required **Thirty (30) Calendar Days**. Bidders should have completed a contract similar to the Project.
3. Bidder/s who bought bid documents in any of the failed biddings will not be charge. A fee of **Five Thousand Pesos (Php 5,000.00) for LOTs 13,14, and15, One Thousand Pesos (Php 1,000.00) for LOTs 11 and 16 and Php 500.00 for LOT 17** will be charged for new bidder/s.
4. Negotiations, Submission and Opening of Best Offer will be on **April 24, 2024, 10:45 A.M.**, at the *3rd floor conference room, DepEd, Schools Division of Negros Oriental, Daro, Capitol Area, Dumaguete City.*

5. Bid Proposals shall include the following (on a sealed envelope):
 - a. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2 of the IRR; and
 - b. Original of duly signed and accomplished Request for Quotation;
6. The Department of Education – Schools Division of Negros Oriental does not assume any responsibility to compensate or indemnify any bidder expenses incurred in the preparation of bid.

The Department of Education - Schools Division of Negros Oriental reserves the right to reject any and all bids, declare a failure, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
