**CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS**

THIS AGREEMENT, made this \_\_\_day of 25 NOV 2021 by and between:

**DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL**, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or **“HOPE”**

-and-

**MARGAL MEDICAL SUPPLIES** with office address at **Palinpinon, Valencia, Negros Oriental** represented by its **Agent, LEXTER LEE M. ALUM**, Filipino, of legal age, and hereinafter referred to as the **“SUPPLIER”**.

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., **Procurement of Medicines, Medical Supplies and Equipment for School Based Feeding Program (SBFP) Beneficiaries and for COVID-19 Compliance During Program Implementation (Lot 2)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Two Million Five Hundred Seventeen Thousand Seventy Pesos (Php 2,517,070.00)** (hereinafter called “the **Contract Price**”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) Philippine Bidding Documents (PBDs);
    - i Schedule of Requirements;
    - ii Technical Specifications;
    - iii General and Special Conditions of Contract; and;
    - iv Supplemental or Bid Bulletins, if any;
  - (b) Supplier’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- (d) Notice of Award of Contract and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Two Million Five Hundred Seventeen Thousand Seventy Pesos (Php 2,517,070.00)** or such other sums as may be ascertained, **MARGAL MEDICAL SUPPLIES** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with its Bid.
4. The HOPE hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
