INVITATION TO BID FOR LOT 1

The Department of Education – Schools Division of Negros Oriental, through the HRTD Funds (PPA 370) intends to apply the sum of Php 5,714,869.00 (Five Million Seven Hundred Fourteen Thousand Eight Hundred Sixty Nine Pesos) being the ABC to payments under the contract for the Provision of Meals, Training Venue, Accommodation and Supplies for the Conduct of 2024 Division Training of Trainers (DTOT) on the MATATAG Curriculum for Teachers and School Heads, details shown below:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Department of Education - Schools Division of Negros Oriental now invites bids for the above Procurement Project. Delivery of the Goods is required within 30 calendar days upon receipt of the Notice to Proceed. Bidders

should have completed, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from Department of Education - Schools Division of Negros Oriental and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM (Monday to Friday).

6. The Department of Education - Schools Division of Negros Oriental will hold a Pre-Bid Conference on March 20, 2024 @ 9:30 AM at 2nd Floor Library Hub, Schools Division of Negros Oriental, Kagawasan Avenue, Capitol Area, Daro, Dumaguete City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the 2nd Floor Library Hub, Schools Division of Negros Oriental on or before 2:00 PM, April 1, 2024.

Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

The Department of Education - Schools Division of Negros Oriental reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
