

# CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS

**DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL**, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or "**HOPE**"

-and-

**MESAM TRADING** with office address at **Plaridel Street, Alang-alang, Mandaue City, Cebu** represented by its **Authorized Representative, ROSELLE G. ZANORIA**, Filipino, of legal age, and hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., **CY 2021 Procurement of Technical Vocational Livelihood (TVL) Learning Tools and Equipment - Lot 1 (Bread & Pastry and Beauty Care Services)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **One Million Five Hundred Fifty-Two Thousand Four Hundred Ninety-One Pesos & 47/100 only (Php 1,552,491.47)** (hereinafter called "the **Contract Price**").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (c) Performance Security;
  - (d) Notice of Award of Contract and the Bidder's conforme thereto; and
  - (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **SUPPLIER**
