 Pursuant to Section 53.1 of the updated 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Department of Education -Schools Division of Negros Oriental, through its Bids and Awards Committee (BAC), invites technically and financially capable bidders to participate in the negotiation for the project: Provision of Venues, Meals, Accommodation and Training Supplies for Various Seminars, Trainings and Workshops Funded by Gender and Development (GAD) for Quarter 1 and 2 of CY 2024 (Negotiated Procurement) with a total Approved Budget for the Contract (ABC) of One Hundred Thirty Nine Thousand Three Hundred Seventy Eight Pesos and 03/100 Centavos (Php 139,378.03), Details as follows:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 3. Bidder/s who bought bid documents in any of the two failed biddings will <u>not</u> be charge. A fee of Five Hundred Pesos (Php500.00) will be charge for new bidder/s.
- Negotiations, Submission and Opening of Best Offer will be on January 30, 2024, 9:30 A.M., at the Library hub, DepEd, Schools Division of Negros Oriental, Daro, Capitol Area, Dumaguete City.
- 5. Bid Proposals shall include the following (on a sealed envelope):
  - a. Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) in accordance with Section 8.5.2 of the IRR; and
  - b. Original of duly signed and accomplished Request for Quotation;

- 6. The Department of Education Schools Division of Negros Oriental does not assume any responsibility to compensate or indemnity any bidder expenses incurred in the preparation of bid.

The Department of Education Schools Division of Negros Oriental reserves the right to reject any and all bids, declare a failure, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
