OJASTRO EdD, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or "HoPE"

-and-

NSSQM Tech Telecommunications Services with office address at Tabuc, San Isidro, Tanjay City, Negros Oriental represented by its Proprietor, NIÑO STANLEY SOL Q. MIRA, Filipino, of legal age, and hereinafter referred to as the "SUPPLIER".

WHEREAS, the ENTITY invited Bids for certain goods and ancillary services, viz., Upgrading Structured Cable System and Augmentation of the Data Center of the DepEd-Negros Oriental Division and has accepted a Bid by the SUPPLIER for the supply of those goods and services in the sum of Eight Hundred Thirty-One Thousand Three Hundred Twenty Pesos only (P 831,320.00) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) Philippine Bidding Documents (PBDs);
    - i Schedule of Requirements;
    - ii Technical Specifications;
    - iii General and Special Conditions of Contract; and;
    - iv Supplemental or Bid Bulletins, if any;
  - (b) Supplier's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

(c) Performance Security;

- (d) Notice of Award of Contract and the Bidder's conforme thereto;
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Eight Hundred Thirty-One Thousand Three Hundred Twenty Pesos only (P 831,320.00) or such other sums as may be ascertained, NSSQM Tech Telecommunications Services agrees to execute and complete the works as provided in the Technical Specifications/Bill of Materials hereto attached as Annex "A" and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with its Bid.
- 4. The **SUPPLIER** further undertakes to provide technical support 24 hours a day, 7 days a week should the need arises.
- 5. The HOPE hereby covenants to pay the **SUPPLIER** in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
