CONTRACT AGREEMENT FOR PROCUREMENT OF GOODS

THIS AGREEMENT, made this ___ day of MAR 01 2023, _____ by and between:

DEPARTMENT OF EDUCATION, DIVISION OF NEGROS ORIENTAL, with principal address at Kagawasan Avenue, Capitol Area, Dumaguete City, Negros Oriental, Philippines, represented by the Schools Division Superintendent **SENEN PRISCILLO P. PAULIN, CESO V**, Filipino, of legal age, and hereinafter referred to as the Head of the Procuring Entity or "**HoPE**"

-and-

PH AND HK FAMILY CORPORATION / SOUTHVIEW HOTEL with office address at Brgy. Banilad, Dumaguete City represented by its **General Manager, JETRYLE RAY L. ALMADIN**, Filipino, of legal age, and hereinafter referred to as the "**SUPPLIER**".

WHEREAS, the **ENTITY** invited Bids for certain goods and ancillary services, viz., **Provision of Meals and Conference/Session Halls for the Conduct of BINHI SA PROBINSYA: Pagsasanay sa mga Makabagong Istratehiya sa Pagtuturo ng Filipino** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **Eight Hundred Fifty-Eight Thousand Six Hundred Pesos (P 858,600.00)** (hereinafter called "the **Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - iv Supplemental or Bid Bulletins, if any;
 - (b) Supplier's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (c) Performance Security;

SUPPLIER agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Eight Hundred Fifty-Eight Thousand Six Hundred Pesos (P 858,600.00)** or such other sums as may be ascertained, **PH AND HK FAMILY CORPORATION / SOUTHVIEW HOTEL** agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with its Bid.
4. **PH AND HK FAMILY CORPORATION / SOUTHVIEW HOTEL** hereby undertakes to provide for the venue, meals, and accommodation with the inclusions, terms and conditions hereto attached as "Annex A".
5. The HOPE hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
