WHEREAS, the ENTITY invited Bids for certain goods and ancillary services, viz., Provision of Meals and Conference/Session Halls for the Conduct of BINHI SA PROBINSYA: Pagsasanay sa mga Makabagong Istratehiya sa Pagtuturo ng Filipino and has accepted a Bid by the SUPPLIER for the supply of those goods and services in the sum of Eight Hundred Fifty-Eight Thousand Six Hundred Pesos (P 858,600.00) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- In consideration for the sum of Eight Hundred Fifty-Eight Thousand Six Hundred Pesos (P 858,600.00) or such other sums as may be ascertained, PH AND HK FAMILY CORPORATION / SOUTHVIEW HOTEL agrees to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects and in accordance with its Bid.
- PH AND HK FAMILY CORPORATION / SOUTHVIEW HOTEL hereby undertakes to provide for the venue, meals, and accommodation with the inclusions, terms and conditions hereto attached as "Annex A".

The HOPE hereby covenants to pay the SUPPLIER in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
